

MEMORANDUM OF AGREEMENT
BETWEEN
Westford School Committee
AND The Westford Education Association

This MEMORANDUM OF AGREEMENT is entered into by and between the Westford School Committee (hereinafter the "Committee") and the Westford Education Association (hereinafter "WEA" or "Association") (collectively hereinafter the "Parties") upon ratification by the Association's general membership and the full Committee.

WHEREAS, the Committee and the Association are parties to a collective bargaining agreement covering the bargaining unit for Unit C for the period of September 1, 2020 through August 31, 2021; and

WHEREAS, the Committee and the Association wish to enter into a successor agreement that reflects all of their understandings and agreements arrived at through said negotiations and both parties are in agreement that, except noted below, there are no additional agreements or amendments to the contract.

NOW, THEREFORE, in consideration of the mutual covenants expressed herein, the Parties agree as follows:

1. The terms and conditions set forth in the Collective Bargaining Agreement for the period of September 1, 2020 through August 31, 2021 shall remain in force for the successor agreement, except as amended herein.

2. DURATION

Section 1. The date of signing this Agreement by the authorized representatives of the Association and the Committee will constitute the effective date of this agreement. The contract will commence July 1, 2021.

Section 2. The Agreement shall remain in full force and effect until June 30, ~~2021~~ **2022**. If a successor agreement is not reached before the expiration date of the existing contract, the existing contract shall remain in full force and effect until the successor agreement is

reached. To renew or amend this contract for the period after June 30, 2021 ~~2022~~, both parties agree to mutually establish negotiations schedules on or before December 1, 2020 ~~2021~~.

3. ATTACHMENT A - SALARY SCHEDULE 2021-2022

The salary schedule for the 2021-2022 school year shall be adjusted by a 2% cost of living increase and applied to all covered Association members effective on Day 1 of the 2021-2022 school year.




